### **ELIGIBILITY & REQUIREMENTS**

The 5<sup>th</sup> Annual "Paint Historic Waxahachie" is open to any artist using *plein air* technique in all fine art mediums. Work submitted should reflect the best quality of your plein air painting. In the spirit of plein air and to "level the field of competition, we ask that all art be completed in the field (no studio touch-up). Artists must agree to paint a minimum 3 days (or sessions) on location during the official 8 day painting period, May 28<sup>th</sup> through June 4<sup>th</sup>, 2010. Canvas, board or paper must be authenticated prior to painting. Artists are required to submit a minimum of 2 paintings for the exhibition and sale. Additional paintings will be accepted based on space available. *Paint Historic Waxahachie* hosted 52 artists during the 2009 event and exhibited 225 paintings.

### **LOCATION**

This paint out coincides with the 42<sup>nd</sup> Annual Gingerbread Trail Tour of Homes. The "Trails" event brings thousands of visitors to Waxahachie the 1<sup>st</sup> full weekend in June. Painting locations will include the 5 historic homes on tour, the Waxahachie Courthouse Square and surrounding Historic District, our city park, and a 5-mile hiking/biking trail that runs through town.

### **OTHER INFORMATION**

The paint out area throughout historic Waxahachie is selected to give artists plenty of exposure and opportunity for sales. Our event publication, "Collector's Guide to a Paint Out" is designed to promote and market the artists, their art and the event. *Paint Historic Waxahachie 2010* is sponsored by the Ellis County Art Association, a 501(c)3 non profit corporation. A portion of the proceeds from the sale of art will benefit the Ellis County Fine Art Museum.



Paint Historic Waxahachie is delighted to have as our distinguished juror, Ms. Kaye Franklin. She is a Signature member Oil Painters of America, Pastel Society of America, Outdoor Painters Society, and Associated Creative Artists.
